## MANUFACTURER'S SUGGESTED RETAIL PRICING (M.S.R.P.)

The manufacturer's suggested retail price (MSRP) is the price that is set out by the manufacturer (Hindle Exhaust Systems) and must be adhered to. A variance of +/- 10% of the MSRP pricing is allowed to accommodate promotions, sponsorships, special discounts, etc. If a violation in pricing has been found and not validated or rectified, this may result in the removal of your dealer account. #### **TERMS**

All orders are subject to the Terms & Conditions below. These terms & conditions may change without notice. All items are in Canadian dollars and will be processed in Canadian dollars. If you are unsure of the current exchange rate, please check with your credit card provider. All orders are subject to verification. If there are any pricing errors or product errors, you will be notified as soon as possible and your order will be updated. Orders may take 2-4 weeks to be fulfilled as the items may not be in stock and may need to be manufactured. We will contact you with an estimated time of shipment once we have received your order. You will receive a confirmation once your order has shipped in full.

## **Shipping Policy**

Ground shipping is via UPS, Dicom (GLS), Loomis, Canpar, Fed Ex or Canada Post and may take 1-7 business days. International Ground Shipping may take 6-12 weeks. Please contact us if you would like to change your shipping option or upgrade to a faster service (additional cost may be applicable). We will notify you once your order has shipped. Please note: shipping costs are estimates and may be subject to change due to number and size/weight of boxes.

#### Return Policy

Product that has been unused and in its original selling condition may be returned up to 30 days after you have received the order. Any used product cannot be returned. Customer must contact Hindle Products Ltd. before submitting a return. The return must be authorized and assigned a RMA number before it can be shipped back to Hindle Products Ltd. Customer is responsible for return shipping charges. Original shipping charges are non-refundable.

### Warranty & Liability

Hindle Products Ltd. warrants this product free from defects in material or workmanship for a period of 12 months from the date of purchase, except as noted. Hindle Products Ltd. will not warrant any product for fitment issues after the system has been used/run on the motorcycle for any length of time. Customer must contact Hindle Products Ltd. prior to sending warranty product. Purchaser is responsible for shipping fees to Hindle Products Ltd. Claims for lost shipment, damaged shipments, or other issues regarding freight must be made directly with the responsible carrier.
